



3. JURIDICTION OF SOCIETY : All over India.

4. DEFINITION

- a) In the rules & regulations, unless the context otherwise requires.
b) Society Shall mean the JEEVAN PRABODHINI, VITA. TAL. KHANAPUR DIST. SANGLI.

c) Executive council means committee of person who are at the time of institute & whom the affairs / responsibilities of the institutes are conferred or vested.

5. MEMBERS :

Members means a person who accept & agree to bide by rules & regulation of the institute & paying sum decided by the executive council

1) Founder member :

First executive council which is signed on the memorandum of association.

2) Genral member :

Those member who pay annual Rs 100/- (Rs. hundred only) with Rs 5/- as entrance fee.

3) Patron Member :

Those persons or institution, who pay minimum Rs. 25,000/- but they have no right to vote (in the election of the institute)

4) Life Member :

Those persons who pays Rs. 10000/- (Rupees ten Thousand Only) as a membership fee.

5) Objects :

Objects means those objects enumerated and explained under par. 5 of the Memorandum of the Institute.

6) Office : Office means the Registered office of the society for the time being.

6. MEMBERS:

- a) Notwithstanding anything contained anywhere in this constitution the signatories of this constitution shall be entitled to be members of institution till their life time.
- b) the Membership may be granted to any person who is the citizen of India Major & of a sound mind &/or to any institution engaged in institute, except as mentioned in clause (c) and (b) here in before on the application to the executive council represented by the president. The executive council shall take the decision in that behalf by majority. The decision of executive council shall be final & conclusive.
- c) The applicant shall not be granted the membership of institution unless he pay & undertake to pay the regular fees as may be fixed by the executive council annually or PRESIDENT, VICE PRESIDENT, SECRETARY other wise of the institute & may breach there shall render the membership of such member liable to be extinguished by the executive council.
- d) The membership of institute shall not be granted to the persons & or institutions by any parental body, for any reason whatsoever, till satisfactory discharge there of & written consent from such organization.

7) Termination of Membership:

The membership of the institution may be terminated in any of the following ways ;

- a) By death
- b) By registration in writing & only after acceptance of the same by executive council.
- c) By default in payment of subscription, annual subscription, for months even after the receipt of notice from the institution.
- d) by expulsion after notice & after inquiry on the ground that the conduct of the member is detrimental to the honour or interest of society or the member willfully & personally refused to comply with the rules & regulations or by law of society provided that such member shall be given an opportunity of being heard & the resolution of expulsion is passed by the majority in general body.

8) RIGHT & PRIVILEGES OF THE MEMBERS:

- i) He / she will be entitled to vote .
- ii) He /she to attend such meeting for which they are called
- iii) He/she entitled to call for any information from the managing council to satisfy his/her demands.


C) Secretary or Director

- 3) Executive council shall consider the annual budget for final approval.
- 4) Executive council : shall be responsible to keep account of the Institute.
- 5) Executive council shall Exercise power to select member of the committees and assign work to the committees.
- 6) Executive council shall reject and refer back any decision of the committees.
- 7) Executive council shall consider any disciplinary action against staff & faculty member.
- 8) Executive council can demand reports, returns & other information from the faculty & inistrative staff.
- 9) Executive council shall meet at least four times in the year on the date to the fixed by the secretary in consultation with president.
- 10) Executive council shall manage & regulate properties & business of the institute.
- 11) Executive council shall accept donations behalf of the institute



- 13) To accept gifts and endorsements on such terms as the institute may consider reasonable.
- 14) To undertake and execute any trust, which the firm institute deems conducive to its object and interest.
- 15) To borrow or raise money, by the issue of or upon bond debentures bill of exchange, if exchange, promissory notes or other obligations securities of the institute or by mortgage or charge or hypothecation of all or a part of the property, movable or immovable or rights of the institute shall think fit and to pay of the funds of the institute all expenses of and including brokerage, commission and all other costs and charges.
- 16) To collect donations and subscriptions for the institute.

15. TO FILL UP VACANCY OF EXECUTIVE COUNCIL:

16. MEETINGS:

a) GENERAL BODY MEETING:

General Body Meeting shall consist of all types of members and shall be held once in every year with the 60 days the closing of the financial year on the date and place fixed by the executive council.

b) EXECUTIVE COUNCIL MEETING:

Executive Council Meeting, if required may be called for any specific purpose by the president.

c) EXTRA ORDINARY MEETING:

Extra Ordinary Meeting, if required may be called for any specific purpose by the president.

d) SPECIAL GENERAL MEETING:

Special General meeting shall be called by the president within a month at any time by requisition in writing signed by not less than 2/3 members of the general body.

17. QUORUM OF THE MEETING:

The quorum for Annual General Body/Special General Meeting shall be 1/4th of the total members, and for extraordinary meeting shall not be less than 5 members. Any of the meeting not having the requisite quorum within half an hour of the time fixed for the meeting shall adjourn. The adjourned meeting will proceed after 30 minutes.

18. NOTICE OF THE MEETING:

Notice of the meeting of executive council, extra ordinary meeting and special committee meeting and Annual General Meetings shall be given at least 10 days before the date of the meeting in such manner as the managing committee shall specify the time and the place where such meeting shall be held. Non receipt of notice by any member will not invalidate the proceedings of any meeting if the regular notice has been issued.

23. DISPOSAT & PURCHASE OF PROPERTY:

Society can purchase and dispose of its own property or assets, if require, but before the disposal of property society shall have fulfill he legal formalities under Bombay Public regstration Act 1950 with Rule 36 to take prior permission of Joint Charity commissioner, Pune.
