The applicant has also filed his affidavit in lieu of examination-in-chief at (Exh.31): Upon perusal of record and proceedings it shows that, the present trust is registered with this office vide P.T.R. No. F-8890/Sangli. As per clause (13) of rules and regulations of present trust the tenure of executive council is of five years. The procedure of election is given in clause (13, 14 and 15). Thereafter, office bearers shall be elected by executive council in their first meeting. Adhere to this, in the annual general meeting of the trust dated 21.09.2022 vide resolution no. 02 new executive council was elected for further period of 2022 to 2027. The notice of annual general meeting was issued by the secretary of the trust to all its members. Thereafter, as per rules and regulations executive council held their meeting dated 03.10.2022 by way of notice dated 23.09.2022. In the executive council meeting dated 03.10.2022 vide resolution no. 02, 03 and 04 office bearers were elected for the period of five years i.e. from 2022 to 2027. The record shows that, all the members in the executive council had been remained present for the executive council meeting and the resolution has been passed unanimously. Consent letter and no objection letter of its members is filed on record. Last change report of the trust Change Report No.2103/2018 for the tenure 2017 to 2022 is accepted by previous authority. The change report is exclusively uncontested one. Hence, I do not find any legal impediment to accept the present change report.
